



































# Laufenberg sustainability goals



# 12 RESPONSIBLE CONSUMPTION AND PRODUCTION

We continuously develop products with defined sustainability benefits, enabling our customers to improve their carbon footprint.

### Our contribution:

- \* 90% PEFC/FSC certified paper products by 2025
- \* 92% sales with sustainable products, of which 25% with recycled content, by 2030
- \* Reduction of indirect specific CO<sub>2</sub> emissions (Scope 3) by at least 20% by 2030
- \* PCF (Product Carbon Footprint) with a simple click by 2030



Continuous innovation and investments in economic and resourceefficient technologies.

#### Our contribution:

By 2030 at the latest, we will

- \* at least halve our specific CO<sub>2</sub> emissions (kg CO<sub>2</sub>e/t)
- \* reduce absolute emissions (kg CO<sub>2</sub>e) by at least 30% (Scope 1&2).
